

# Matters to be notified under the Personal Data Protection Act and consent form

The health care group of the Student Affairs Office of National Kaohsiung University (hereinafter referred to as this team) obtains the personal health information provided by you in accordance with the provisions of Article 8 of the "Personal Data Protection Law". It needs to inform the following matters and obtain your consent. Please read it carefully .

If you are under the age of 18 , you should ask your legal representative to read, understand and agree to all the contents of this agreement and the subsequent amendments and changes, and sign this agreement. When you tick "I Agree" and sign this agreement, it means that you have read, understood and agreed to accept all the contents of this agreement and its subsequent revisions.

## 1. Purpose of collection:

In order to implement and improve the health management work of National Kaohsiung University (hereinafter referred to as the school), in order to maintain and promote the health of students.

## 2. Categories of Personal Data Collected:

- (一) Basic personal information: including student number, department of study, name, date of birth, blood type, gender, ID number, contact address, telephone number, and emergency contact information.
- (二) Basic health information: including personal medical history, special disease status or precautions, major injury and disease certificate card collection and its category , disability handbook collection and its category level, family medical history, etc.
- (三) Life review of the past year.
- (四) Self-Health Assessment.
- (五) Health check items include:
  - 1. Physical examination: physical examination, vision and eye examination, oral and dental examination, ENT examination, head and neck examination Internal examination, chest and abdomen examination, spine and extremities examination, skin examination.
  - 2. Laboratory examination: urine, blood routine, cholesterol, kidney function, liver function and hepatitis B surface antigen antibody examination.
  - 3. Chest X-ray.

## 3. Period, region, object and method of personal data utilization :

- (一)Period: During the schooling period, students' health information shall be followed in the "Implementation Measures of National Kaohsiung University Student Health Examination" The retention period of the card is seven years after the student leaves school or withdraws from school.
- (二)Objects: Provided to relevant teachers, tutors, physical education teachers for counseling, caring or arranging adaptation to physical education Courses; or provided to the Ministry of Education for statistical or academic research needs.
- (三)Method: By means of computer or non-computer use .

4. In accordance with Article 3 of the Personal Data Law, you may exercise the following rights regarding your personal data retained by the school :

(一) Inquire, request viewing or request a copy.

(二) Request for supplementation or correction, but please provide an explanation in accordance with the law .

(三) Request to stop collection, processing or use, and request deletion.

To reject the application in accordance with the provisions of the Personal Data Protection Law , and the school will not be liable for compensation if your rights are damaged due to your exercise of the above rights.

5. **You are free to choose whether to provide relevant personal information:**

You are free to choose whether to provide personal information. If you refuse to provide the required personal information or provide incomplete information, the school will not be able to provide you with complete care and services. Please forgive me .

If the content of the above personal data protection law should be notified is updated, please refer to the announcement on the school website for details of the updated content, and no individual notification will be made.
